23/00680/FUL. Albion Hotel, Gate Lane, Freshwater Bay.

Proposed landscape alterations to form terrace.

Freshwater Parish Council object to this application for the following reasons:

It will block access to the western beach for emergency vehicles, and to those with disabilities or challenges walking to both, making the area unsafe and reducing the utility and enjoyment of the beach for locals and visitors alike.

The land is owned by the public realm and used continuously by locals and visitors throughout the year. As the terrace is for use by hotel residents only the scheme would greatly reduce the utility of the publicly owned area for the public.

The parish council support the comments made by Island Roads and Public Rights of Way who raised objections to this application.

If the planning authority is minded to approve this application the parish council request that conditions are in place that improve the footpath and safety/access of the proposed design to the western end of the beach.
