6. PLANNING APPLICATIONS TO BE DISCUSSED (AT TIME OF SENDING OUT NOTICE).

23/00610/FUL. Albion Hotel, Gate Lane, Freshwater Bay.

Proposed single storey extension on west and south elevations; porch canopy; alterations to fenestration and balconies.

Freshwater Parish Council unanimously accept the application with no objections.

23/00624/RVC. Land to the East of Birch Close and North of Solent Gardens.

Removal of condition 11 on 21/00357/FUL relating to the establishment of a Traffic Regulation Order to secure implementation of double yellow lines about the junction of Birch Close with Colwell Road.

Freshwater Parish Council unanimously objected to this application; The Parish Council support the objections raised by Island Roads and uphold the TRO condition. It was agreed that Cllr Cox as current IWALC representative for IWC Planning Committee will be provided with a formal statement from the Parish Council if this application goes to the IWC Planning Committee.
